## **Facts**

The facts detail a calculated evolution of tactics by the State Party spanning 1972–2025, divided into two phases:

## Phase I (1972–2000): Foundational Crimes.

I was subjected to severe physical and mental torture, including clandestine electroshock conditioning, drug-facilitated abuse (forced infertility), and "mind control" sessions conducted by state-connected actors, including Joris Demmink (later Sec-Gen of Justice). These acts were allegedly protected by a 1973 Royal Decree ensuring total

impunity.

### Phase II (2000-Present): State Cover-up.

When my memories returned, the State initiated a campaign of "institutional gaslighting." Rather than investigate, authorities weaponized psychiatry to label me with "delusional disorder," ignoring clinical evidence of C-PTSD and Structural Dissociation. In 2003, my legal insurance (DAS) was fraudulently cancelled via coerced drugging (Ketamine) to financially disarm me. The State has since maintained a systemic obstruction of justice to protect high-level perpetrators.

Domestic remedies have not been exhausted because they are unavailable, ineffective, and actively foreclosed by the State Party (Art. 22(5)(b)).

- 1. Systemic Denial of Counsel: A "cordon sanitair" exists where hundreds of lawyers have refused representation since 2004, plausibly due to an illegal "secret curatele" (guardianship) rend
- 2. Police Obstruction: In 2004, the Ministry of Justice explicitly forbade the police (Det. Bruinsma) from creating the mandatory proces-verbaal, blocking any criminal investigation at the sour
- 3. Judicial Blockade: The Court of Appeal (2005) and Ministry of Justice (2025) summarily rejected complaints without hearing witnesses or responding substantively.

The State's final refusal on Nov 13, 2025, confirms that all domestic avenues are closed.

- 1. Cessation of Harm: The State must immediately cease all harassment/surveillance and preserve all intelligence files (AIVD/Ministry of Justice) regarding this case.
- 2. Lift Legal Blockades: Immediate removal of any "secret curatele" impeding my legal capacity.
- **3. Legal Aid Fund:** The immediate establishment of a Legal Aid Fund, paid into an independent "Stichting" (Foundation) to bypass state interference. This is the only way to remedy the "cordon sanitair" that has denied me legal representation for 20 years.

I have much more information since 2007 detailed in 730+ articles about all the crimes committed to me and my girlfriend, wife and now forced ex-wife.

All easily to find as it is chronological with date, name of persons involved, explanation and evidence of official reactions if any.

I have published these on my Blog hanssmedema.info as advised by American Miami Immigration Court Judge Rex J. Ford in 2009 during my first Asylum request against the Netherlands.

My case was so extreme after 7 months FBI/CIA investigations that he and DOJ found 5 grounds/Nexus for Asylum, what never happened before in the known history of America.

In total I have been in Innocent detention for 29 months (15 in America and 14 in the Netherlands), because the Netherlands refused to simply investigate my charges.
