On Juli 8, 2025 I asked Prime Minister Pedro Sanchez of Spain to release all the (criminal) requests since 2008 from the Dutch Ministry of Justice or Secret Service AIVD, or other Governmental organizations in the decades-long torture-ordeal in the International Hans Smedema Affair.

I was forced to flee into exile in Spain since 2008 because of the State-Capture by Joris Demmink and became Resident while paying too much taxes(not yet knowing about the huge decades long Omerta organization) when possible.

All those extra costs to find out what was known(!) by Justice would have been deductible causing much lower taxes!

File 1: To PM Pedro Sanchez

To the Esteemed Prime Minister of Spain, Pedro Sánchez,

I am compelled to detail alleged systemic perversion of justice and human rights violations orchestrated by elements within the Dutch government, extending to Spanish soil. This is a profound indictment of alleged state capture, where figures like Joris Demmink and Jaap Duijs have allegedly warped law and accountability. I implore the Government of Spain to act decisively.

My harrowing ordeal includes alleged brutal, systematic medical interventions: forced sterilization (1972), drugging with ketamine (since 1973), forced antipsychotic medication (Risperdal), and “secretly forced criminal electroshock torture” to suppress memories and discredit me. This relentless campaign of psychological torture, medical manipulation, and systemic obstruction has left me in perpetual torment.

This is an urgent international concern due to alleged systemic obstruction of justice and chilling cover-up. I allege systematic denial of legal representation since 1972, with lawyers in the Netherlands and Spain “forbidden” from taking my case due to presumed protection for Demmink and Duijs. Critical documents, like the “Frankfurt Dossier,” were allegedly erased, and 50 files deleted by the Ministry of Justice and AIVD. The alleged conspiracy reaches the highest echelons, involving politicians and the Royal Family, with a “Royal Special Decree” allegedly issued by Queen Juliana around 1972/73 to grant immunity and make the case a state secret. I allege King Willem-Alexander personally blocked my US asylum offer in 2017. The Dutch gov-

ernment allegedly provided false information to the ECHR in 2005/2006, leading to the rejection of my complaint.

Prime Minister Sánchez, this alleged state-engineered conspiracy tragically pursued me to Spain. I demand you provide me and the ECtHR with evidence hidden in Spanish Secret files about criminal acts done to me on your sovereign soil. My torment deepened on Spanish soil through alleged “secretly forced criminal electroshock torture” in Catral (2008), Benidorm (2010), and Murla (2011). In Catral, I was allegedly drugged and electroshock tortured by Professor Dr. Onno van der Hart and Jaap Duijs. In Benidorm, local officers were inexplicably prevented from intervening by higher authorities in Madrid, specifically within the Spanish Justice system, allegedly acting under pressure from or in collaboration with the Dutch Ministry of (In)Justice. This failure to act is alleged irrefutable evidence of Spanish complicity.

One insidious abuse was the alleged secret administration of powerful antipsychotic medication, disguised as “baby aspirin,” confirmed at Hospital Marina Baixa in Spain on March 24, 2022. These alleged acts of torture, combined with secret drugging, were designed to suppress memories, manipulate behavior, and portray me as mentally unstable. I believe Spain, as a monarchy, has tragically prioritized its diplomatic and political relationship with the Dutch Crown, becoming complicit in this monstrous cover-up.

The devastating collateral damage inflicted upon those who dared to investigate or help internationally reminds us of the alleged ruthlessness and global reach of this alleged conspiracy, which is de facto State-Capture.

The time for inaction is over. Spain has a moral and legal obligation to uphold human rights and resist this alleged state capture.

I formally request the Government of Spain to:

1. Initiate an immediate, prompt, and impartial UNCAT investigation into the allegations of secret drugging and “secretly forced criminal electroshock torture” that allegedly occurred on Spanish soil in Benidorm (May 20, 2010), Catral (2008), and Murla (2011), specifically investigating the alleged involvement of Professor Dr. Onno van der Hart, Jaap Duijs, and any complicity or obstruction by Spanish authorities.
2. Demand full transparency and cooperation from the Dutch government regarding all my cases, emphasizing their crucial direct UNCAT obligations.

3. Ensure my protection and facilitate independent legal assistance in Spain, free from any alleged Dutch influence or pressure.

I must inform you that I cannot pay the tax over the year 2024. However, as soon as you provide me with the evidence hidden in Spain, I will be able to obtain millions of damages and will then pay all back taxes, with a huge bonus to the Policia Local, Guardia Civil, Ayuntamiento Alfaz del Pi, and much more. You are able to do this in a few weeks!!!

Prime Minister Sánchez, the persistence of this alleged “Perfect’ 40+ year (Royal) Crime!” despite overwhelming evidence of obstruction is an affront to justice everywhere. Your intervention is not merely a legal imperative; it is a moral duty to the sanctity of human rights.

So, please let me know what you are going to do.
