

## **ANNEX 11 - Dossier Médico y de Trauma (Ing. Hans Smedema): Urgent Medical Warning establishing the absolute contraindication for antipsychotic medication and exposing the health risks of the falsified Dutch psychiatric history**

### **1. Factual Background: The Clinical Warning and Falsified History**

Annex 11, titled the *Dossier Médico y de Trauma*, is an urgent, dual-purpose medical and forensic document designed to be presented to general practitioners, hospitals, and specialized trauma professionals (such as Centro Sira in Spain) 1. The primary function of this document is to establish an absolute medical contraindication against the prescription or administration of any antipsychotic medications (such as Risperdal/risperidone or haloperidol) to the complainant under any circumstances 2.

The document forensically clarifies that the complainant's Dutch medical files—which contain weaponized diagnoses of "delusional disorder," "paranoia," or "schizophrenia"—are entirely falsified 2, 3. These diagnoses are the product of documented institutional abuse and a state-sponsored cover-up in the Netherlands, rather than endogenous psychosis, a fact externally validated by US Immigration Judge Rex J. Ford in 2009 2, 3.

Crucially, the dossier warns Spanish healthcare providers of the **Severe Neurological Risk** the complainant faces. Due to a history of Traumatic Brain Injury (TBI) resulting from secretly forced high-voltage electroshock torture, the administration of antipsychotics to an elderly patient with this specific neurological profile can actively impede brain recovery, cause accelerated cognitive decline, severe orthostatic hypotension (fall risk), and life-threatening cerebrovascular events (strokes) 4, 5.

### **2. The Threat of Covert Chemical Subjugation in Spain**

Annex 11 formally notifies the Spanish medical system that the complainant has been the victim of covert chemical subjugation on Spanish soil. For years, powerful antipsychotics (Risperdal) were secretly administered to him, fraudulently disguised inside official boxes and blister packs of "100mg baby aspirin" 4, 6. This clandestine poisoning was objectively confirmed on March 24, 2022, by an independent anesthetist at Hospital Marina Baixa in Spain 4, 6.

Despite this objective medical discovery and the formal issuance of the *Dossier Médico y de Trauma*, the Kingdom of Spain and its medical institutions continue to enable a healthcare environment where covert chemical subjugation remains a critical, life-threatening risk 3. The Spanish system's continued reliance on fraudulent Dutch psychiatric flags perpetuates the victim's vulnerability to extreme medical malpractice 3, 7.

### **3. Legal Significance for UNCAT Proceedings against Spain**

Annex 11 serves as a critical medical and legal foundation in the UNCAT communication against the Kingdom of Spain. It establishes the immediate physical danger posed by the state's inaction and triggers the following legal mechanisms:

**A. Complicity in Cruel, Inhuman, or Degrading Treatment (Article 16)** By officially warning the Kingdom of Spain of the acute neurological risks of antipsychotic administration and the fraudulent nature of the exported Dutch psychiatric files, Annex 11 removes any defense of "medical ignorance" 3. Spain's failure to empirically verify these foreign psychiatric flags and its unquestioning acceptance of fraudulent medical directives makes the state fully liable for the severe health risks imposed upon the complainant 7. Allowing the Spanish healthcare system to be utilized for the covert administration of mind-altering substances to a healthy individual constitutes active facilitation of cruel, inhuman, and degrading treatment 7.

**B. Core Justification for Urgent Interim Measures (Rule 114)** Annex 11 provides the indispensable clinical evidence required to petition the UNCAT Committee for urgent Interim Measures to prevent "irreparable harm" 8. Specifically, this dossier is the legal basis used to demand that the UNCAT Committee compel the Kingdom of Spain to enact an **Enforcement of Medical Contraindication Injunction** 9.

The complainant uses Annex 11 to formally request that the UNCAT Committee order Spain to:

- Issue a binding, system-wide medical injunction across its national health infrastructure (including all local *Farmacias* and Hospital Marina Baixa) enforcing an absolute contraindication against the prescription, administration, or covert dispensation of any antipsychotic medication to the complainant 9.
- Cease all reliance on the fraudulent, weaponized psychiatric files provided by the Dutch Ministry of Justice, which pose an imminent threat to the complainant's physical and neurological health 9.
- Facilitate an independent forensic medical evaluation of the complainant under the UN Istanbul Protocol by the Basque Institute of Legal Medicine, utilizing the Torturing Environment Scale (TES 2.0), to objectively document the physical and psychological injuries detailed in the dossier 8.

**Conclusion** Annex 11 (*Dossier Médico y de Trauma*) is a vital clinical safeguard and forensic evidentiary document. It proves that the Kingdom of Spain was explicitly warned of the life-threatening neurological risks posed by the ongoing chemical subjugation of the complainant. By demonstrating the medical reality of the falsified Dutch psychiatric history, Annex 11 justifies the immediate necessity for UNCAT-mandated interim measures to halt the weaponization of the Spanish healthcare system and prevent irreversible physical and cognitive destruction.
