

# The Unveiling of Truth: A Chronicle of Decades of State-Sanctioned Abuse and Obstruction

(Proposed Attachment for the National Ombudsman)

## I. The Unfolding Nightmare: A Chronicle of Gruesome Abuse and Malicious Manipulation

The "Hans Smedema Affair" is not merely a legal case; it is a chilling chronicle of pervasive, systematic psychological and physical abuse, meticulously orchestrated and concealed for over five decades. This horrifying ordeal began in 1972 when Hans Smedema's then-girlfriend, Wietske Jansma, was directed to rent a room from Jan van Beek in Utrecht by her colleague, Yvonne Stuivenberg, Jan van Beek's wife. It was in this "horror" room that the systematic drugging and sexual abuse of Wies commenced, a torment that tragically continues to this very day.

The sheer depravity of this case is underscored by the horrifying fact that Hans Smedema was secretly rendered infertile in 1972, a cruel truth deliberately hidden from him. While he was misled into believing he was the father, his wife bore children who were, in reality, the offspring of her rapists. The names of these alleged perpetrators are known and have been repeatedly presented, yet consistently ignored: Jan van Beek from Utrecht, implicated in abuses from 1975 onwards; Jan de Vries from Leeuwarden, involved since 1977; Rieks P. from Roden, whose alleged atrocities date from 1980; and Jaap Duijs from Drachten, who is also accused of causing an abortion in 1980. The absolute refusal to conduct a simple, verifiable DNA test, which would immediately expose the truth, is a monstrous act of complicity, denying fundamental human rights and perpetuating this unspeakable fraud.

Beyond the physical violations, the psychological torture inflicted upon Hans and Wies is a testament to the sadistic brilliance of their tormentors. They were subjected to "brainwashing," "drugging," and "electroshock" treatments, explicitly designed to induce amnesia and maintain their "defenselessness against the rapists". This psychological assault included the daily, clandestine administration of a "baby-aspirin-antipsychotic", turning Hans into a "half zombie who can no longer think normally". His wife, tragically, developed a "double personality" or "emotional personality," a direct consequence of the severe trauma, and was maliciously manipulated to sign documents and make statements against Hans, further isolating and victimizing him.

Hans Smedema has chillingly dubbed the clandestine operation behind this cover-up the "Koninklijke Criminele Organisatie Mengele (KCOM)," a horrifying "false tribute" to Professor Dr. Onno van der Hart, who is accused of orchestrating this medical deception. This criminal organization, allegedly operating under the direct purview of "The Crown," specifically Queen Beatrix, prioritized the untouchability of its name above the ruined lives of innocent victims.

## II. The Iron Curtain of Impunity: Systemic Obstruction of Justice

The terrifying reality of the Hans Smedema affair is deeply intertwined with the alleged untouchability of certain high-ranking figures within the Dutch justice system. At the epicentre of this systemic corruption are Joris Demmink and Jaap Duijs, whose alleged roles in enabling and perpetuating this horrific abuse are staggering.

The Untouchability of Joris Demmink and Jaap Duijs:

- **Joris Demmink, the Alleged "Untouchable Secretary-General":** Joris Demmink, identified as a "heavy corrupt serial rapist" and the "top-level criminal Secretary-General" of Justice from 2002 to 2013, is unequivocally accused of being "totally unchecked" in his alleged criminal activities. He is consistently implicated in blocking thousands of cases, systematically destroying evidence, and manipulating information to his advantage. Reports from former top officials within the Ministry of Justice, who worked directly under him, corroborate his immense power, allegedly built on "terror" and an "extensive and powerful network". Damningly, multiple sources explicitly link him to a "large pedophile network in The Hague" involving other "high top officials and politicians". The "Wabeke-papers," a detailed report from a former coordinating chief public prosecutor, allegedly confirm Demmink's pedophilia and involvement with a "young Czech who played in porn films" and visiting "gay bars" in Prague with a Dutch ambassador. His lawyer, Harro Knijff, from the powerful law firm De Brauw Blackstone Westbroek, is accused of using threats and intimidation to silence

media and individuals who dared to speak out against Demmink, with one of his own companies even bearing the name "Pinokkio".

- Jaap Duijs, "The Monster of Drachten": Jaap Duijs is portrayed as "the Monster of Drachten" and the "Vaginajager" (vagina hunter), a moniker reflecting the brutal nature of his alleged crimes. He is accused of years of systematic abuse against Hans's wife, impregnating her in 1980 (resulting in an abortion), and actively manipulating her through "mind control" to obstruct investigations and destroy critical evidence, including stolen documents and deleted emails. Duijs is alleged to be an AIVD (Dutch secret service) agent, a key figure within the "Omerta" organization, and directly responsible for Hans's daily micromanaged torment. Shockingly, despite knowledge of his alleged actions, the police and public prosecutor (OM) allegedly consistently dismissed prosecutions against Duijs, a horrifying pattern attributed to Joris Demmink's pervasive influence.

Denial of Legal Recourse: A Barred Path to Justice (Since 1972/2000):

Hans Smedema's desperate quest for justice has been met with a brick wall of institutional refusal. He has been systematically denied legal assistance, with "hundreds of lawyers" explicitly refusing his case, often citing "no time" or, more chillingly, an unspoken prohibition against assisting him. Even prominent lawyers like Mr. A. (Bram) Moszkowicz, initially taking the case, were allegedly intimidated by the FIOD (Fiscal Intelligence and Investigation Service) and subsequently barred from mounting a proper defense, including denying crucial DNA testing and the testimony of key witnesses. This systematic denial of legal representation, described as "Kafkaesque," leaves victims like Hans Smedema "powerless" and "almost rightless".

Corrupt Courts and Biased Officials:

The Dutch legal system itself stands accused of profound corruption and complicity. Judges, particularly Politierechter Mr. Jeroen van Bruggen, are alleged to be "corrupt" and "clearly biased," actively participating in the cover-up. Hans was denied the right to an attorney, to hear witnesses under oath, and to obtain vital DNA paternity tests. Court proceedings are described as "pro forma" or "sham trials" with predetermined, unjust outcomes, where crucial information is deliberately withheld from the judges themselves. The Ministry of Justice and the Public Prosecution Service (OM) are repeatedly accused of "obstruction of justice," refusing to register official complaints, and actively concealing or fabricating evidence. This alleged "organized crime" within the Justice system is said to operate under political approval, including from figures like MP JanPeter Balkenende and Ministers Donner and Hirsch Ballin.

Erasing the Truth: The Destruction and Manipulation of Evidence:

A core tenet of this horrifying cover-up is the systematic destruction and manipulation of crucial evidence. Police files that "should have been there" were reported missing as early as 2000. The "Frankfurt Dossier" from 1983, containing intelligence files about Hans and his family from the General Army Hospital in Frankfurt, was allegedly erased, despite Captain Rust's later confirmation of its contents. DNA paternity tests, which could unequivocally prove the identity of the children's fathers, have been either denied or allegedly falsified. Medical files, including MRI scans, were allegedly "manipulated" or "falsified". Even efforts to obtain documents through the Wet open overheid (Woo) have been met with the chilling response that "no documents with the requested information were found," strongly suggesting continued active suppression. This deliberate erasure of truth creates a "cordon sanitaire" around the victims, isolating them and denying them access to critical information about their own lives.

III. Collateral Damage: Lives Crushed in the Shadow of Power

The tentacles of this alleged "Royal Criminal Organization Mengele" extend far beyond Hans and Wies, ensnaring and devastating the lives of those who dared to investigate, help, or were simply in their orbit.

Brave Individuals Silenced or Ruined:

- Mr. Ruud Rosingh, Head Public Prosecutor (Leeuwarden): In 1991, Mr. Rosingh, acting with integrity, initiated an investigation into the rape of Hans's wife. However, he was "immediately forced" by the College of Prosecutors General in The Hague to halt the investigation, reportedly under orders stemming from a letter

written by Hans's brother, Johan Smedema. Following his refusal to comply initially, he was "immediately transferred" to Zwolle, indicating the immense pressure exerted by this shadowy organization. His case exemplifies how individuals within the justice system who attempt to act ethically are swiftly removed or silenced.

- Cees van 't Hoog (Neighbor): In a truly horrifying turn of events, Hans's neighbor, Cees van 't Hoog, was allegedly "murdered in 1980 on direct order of Joris Demmink" after his independent investigation brought him "too close to the truth". His family is reportedly aware of the circumstances surrounding his death, but the full extent of this atrocity remains concealed.
- Unnamed Military Neighbor and Nephew Jack: A military neighbor who discovered Hans's daily drugging in 1975 and reported it was "immediately criminally attacked by Justice and Defense" (with Joris Demmink implicated) and forced to sell their home and move. Similarly, Hans's nephew Jack, a State Police officer, was "immediately dismissed" from his job after reporting Hans's mistreatment, and his subsequent lawsuit was manipulated to exclude Hans. These cases illustrate the devastating personal cost of challenging the alleged state-sanctioned cover-up.
- Captain/Major Al Rust (U.S. Military Intelligence): In 1983, during a standard screening in Frankfurt, Captain Rust's intelligence unit found that Hans was being "deceived by the Dutch government." After further investigation, he identified Professor Onno van der Hart as the "enemy" who had "brainwashed" Hans. Rust faced severe repercussions, including a "dishonorable discharge" and financial ruin, because the Dutch government refused to admit its complicity. He later managed to obtain copies of the "disappeared secret files" from Germany, proving his innocence and receiving full rehabilitation in the US, but not without immense personal suffering.
- Stella van Arkel (Secretary): Hans's former secretary, Stella van Arkel, was allegedly dismissed from her job at Euro-Routing after urging Hans's brother Marinus to intervene when Hans's daughter called about "angry Mr." Rieks P. assaulting her mother. Stella initially bravely supported Hans but later denied everything, possibly due to intimidation, being labeled "schizophrenic".

#### The Media's Complicity and Censorship:

A chilling aspect of this affair is the alleged widespread censorship within the Dutch media. Major outlets, including The Telegraaf, Friese Pers, and organizations representing chief editors, are accused of refusing to publish Hans's story. This silence is attributed to an "Omerta" – a code of silence – enforced by threats from Demmink's powerful legal team. There are even grim allegations that directors of media outlets who attempted to investigate this case suffered suspicious "car accidents" or developed fatal illnesses like "cancer," hinting at extreme measures to enforce secrecy.

#### Family Betrayal:

Hans Smedema's own family is tragically implicated in the cover-up. His brothers (Johan, Marinus, Ruud) and sisters-in-law (Klazien, Betty) are accused of being part of "Group Mengele," actively denying the truth and even attempting to drug Hans to maintain his amnesia. His brother Johan Smedema is explicitly named as the "Judas" and "leader" orchestrating the family's involvement with Justice. His wife, a victim of severe manipulation and dissociation, is also tragically implicated in actions that have inadvertently served the agenda of her tormentors and the cover-up.

#### Professional and Financial Devastation:

The psychological and legal battle has left Hans Smedema's life in ruins. He lost his distinguished career as a top headhunter, becoming "completely incapacitated" in 2004 due to the immense stress and manipulation. This has resulted in catastrophic financial losses, amounting to millions of euros in lost income and pension accrual. Furthermore, Hans Smedema was unjustly incarcerated for 29 months and outrageously forced to pay €6800 to his wife's rapists as a "fine," a ruling he vehemently refuses to acknowledge as legitimate.

#### IV. The Ombudsman's Role: A Betrayal of Trust

The National Ombudsman, entrusted with safeguarding citizens' rights against governmental misconduct, has tragically and repeatedly failed Hans Smedema, effectively becoming another layer in the pervasive cover-up.

### Repeated Rejections: A Pattern of Denial:

Hans Smedema's complaints to the National Ombudsman in 2005 and 2008 were dismissed, characterized by "heavy errors" and "obstruction" from the Ministry of Justice and Joris Demmink himself. The Ombudsman allegedly denied having the authority to intervene because "Queen Beatrix is involved," a crucial fact shamefully concealed from Hans. The current (third) complaint, submitted in 2025, was once again dismissed by a complaint handler who professed to "know nothing of this case" and misinterpreted it as a mere financial dispute, ignoring the continuous nature of the crime and the decades of denied justice.

### Contradiction with Mandate and Public Trust:

These rejections stand in stark contradiction to the Ombudsman's explicit mandate to investigate "systemic maladministration and human rights concerns" and to evaluate the "propriety" of administrative actions, which encompasses fairness, transparency, and good governance, even in the absence of explicit legal violations. As highlighted by university research, governmental authorities can "grossly violate" their duties, using "rule of law means" to perpetrate injustice. The National Ombudsman, Reinier van Zutphen, has himself publicly acknowledged that his office's recommendations are "scarcely followed" by authorities, indicating a systemic lack of accountability.

### The Chilling Impunity of Power:

The Ministry of Justice and Security, through Minister David van Weel's recent response (February 4, 2025), cynically dismissed Hans's detailed allegations as "insufficiently substantiated" and lacking grounds for state liability, while simultaneously advising him to "contact a lawyer," fully aware of the systematic denial of legal aid he faces. This is presented as deliberate obstruction and fraud, with critical files allegedly "wiped" or "manipulated" at higher echelons within the Ministry. Documents pertaining to Hans's UNCAT (United Nations Convention Against Torture) case, initiated by President Obama in 2017, are likewise claimed to be "not found" by the Ministry of Justice, yet their existence is documented and verifiable through international channels. The consistent denial of access to files by the "Omerta department" is a brazen act of contempt for justice.

This is a case where the very mechanisms designed to protect citizens have allegedly been co-opted to perpetuate and conceal unspeakable crimes, allowing figures like Joris Demmink and Jaap Duijs to operate with unimaginable impunity. The National Ombudsman's continued inaction serves only to entrench this horrifying reality, making the office a silent accomplice in a profound betrayal of the Dutch people.
